The Centers for Medicare & Medicaid Services (CMS) Finalizes Emergency Preparedness Requirements

Patient safety comes first. That is the message from CMS. Providers must be ready to ensure that patients' care is not disrupted. All healthcare providers must follow four best practice standards for emergency preparedness by developing:

1. An all-hazards emergency plan.
2. A coordinated communications plan.
3. A training program.
4. Policies and procedures based on the emergency plan.



All plans must be tested, at least annually. While natural and man-made disasters will always pose a threat to patients, the providers will now be ready.
